

READ CHECK LIST (print and keep).

1. **READ FAMILY LETTER** (print and keeps).
2. **PRINT AND FILL OUT APPLICATION TO PARTICIPATE** (It is important that you fill out ALL information required). **SEND TO ADDRESS BELOW WITH RELEASES!!**
3. **PRINT AND FILL OUT ADULT PARTICIPATION RELEASE FORM -1 EACH PER ADULT** (Fill out ALL information on release(s), your name goes at the top of the Adult Release(s)). **HAVE NOTARIZED AND SEND TO ADDRESS BELOW.**
4. **PRINT AND FILL OUT THE MINOR RELEASE FORM – 1 EACH PER CHILD ATTENDING.** (Fill out ALL information on these release(s), each child's name goes at the top of each minor release.) **HAVE NOTARIZED AND SEND TO ADDRESS BELOW.**
5. **EVERY ADULT AND EVERY CHILD MUST HAVE A SEPARATE RELEASE FORM FILLED OUT AND RETURNED TO US AT ADDRESS BELOW! No adult or child will be allowed to participate if they have not signed a release,** or signed one for each child and filled out all of the proper paperwork on our website and the required paperwork at registration and/or at the track.
6. **EACH ADULT AND CHILD THAT WANTS TO RIDE IN THE RACECARS OR WANTS TO GO TO THE PITS TO WATCH MUST HAVE SHORT SLEEVED SHIRTS (NO TANK TOPS), LONG PANTS AND CLOSED TOED SHOES!!** This is track rule and must be followed...you can wear shorts or open toe shoes when you are not in the pits, but absolutely not while participating in rides, watching or helping in the pits.
7. **ABSOLUTELY NO CHILD UNDER 18 CAN BE WITHOUT CONSTANT SUPERVISION FOR EVENT WEEKEND. PLEASE KEEP YOUR CHILDREN WITH YOU AT ALL TIMES!!**
8. **CHECK OUT ALL THE MAPS AND OTHER INFORMATIN ON RACEREV.COM TOO!!**

HERE IS A QUICK CHECK LIST FOR YOUR TRIP

At the track and hotel: All necessary paperwork.

- Any medicine needed for the weekend.
 - **Long pants and closed toed shoes for "Hot Pit" activity.**
- Hats for sun protection.
- Sunscreen.
- If you still have your Balaclava (head sock) from previous years, please bring them.
- Lawn chairs.
- Maps.
- Any extra pillows or blankets for your comfort at the Hotel....tip...Use colored or printed pillow cases or blankets and keep them separate from the Hotels!
- In the past some families with lots of "Kids" suggest that you might want to bring inflatable air mattress to prevent overcrowding in a bed.
- Remember: NO roller blades, bikes, skate boards or any people moving devices. ONLY wheelchairs allowed!! (if you need one bring one as we do NOT have wheelchairs.)
- Chemo patients may want to bring nausea bags if needed.
- Helpful hints:

 - Tooth brush(s) and Paste
 - Swim suits for Friday night
 - Beach towels
 - Camera's
 - Extra dry socks in case of rain
 - Rain protection – poncho &/or umbrella
 - Change of clothes for Saturday night banquet
 - Positive attitude of having fun. Remember courtesy to everyone

Breakfast will be served after 6:00 am at the Quality Inn, Sebring, Florida and you will enjoy lunch both days at the track with a special Banquet Dinner on Saturday Night in the Quality Inn Main Ballroom. The children and their parents will receive rides in real race or track cars both Saturday and Sunday and there will be lots of other activities all weekend long!! Because of the extensive amount of planning for hundreds of people for the weekend, we need your cooperation in carefully reading and filling in all application questions, signing all waivers and promptly returning them to Zoeller Ministries KRF, P.O. Box 100828, Cape Coral, 33910. You WILL ONLY be notified IF we have met our quota early and don’t have any more room. So when you send in your paperwork, we are assuming you will be attending the KRFL event, and we MUST hear from you if you can NOT come for any reason, so that your room can be given to another family. All information is made available for you ONLINE for your convenience. Please make sure that you print out this letter which you need to keep with you, along with Maps and Hotel information. Print out the Registration Application, Waivers and a Zoeller Ministries Minor Release Form (1) per each child that will be coming to the track with you and send to the address above. Please give us all information to ensure correct sizing, proper amounts of food for each meal without waste and the best weekend experience possible. Thank you for your cooperation!

- Each family needs to remember to bring long pants, a short sleeved shirt, and closed-toed shoes (NO flip flops) for each one of you. NO ONE can ride in the racecars or even be allowed in the pits without them. This is mandatory per track regulations and cannot be waived. The track is now owned by ISC (NASCAR) and safety is much stricter and enforced.
- Please don’t bring any scooter, skates, bicycles, etc. to the track, as they are NOT allowed! Wheel chairs of course are acceptable! We usually have one or two that you can borrow if you need one!!
- Please let your family know that they are guests of the Sebring International Raceway, sanctioned by the PBOC, and Zoeller Ministries, Inc. and they are expected to obey and respect all rules!!! This is a family event and there is to be absolutely NO Alcohol or illegal drugs at the track.

Check out time is Sunday Morning 9:00 AM. GO IMMEDIATELY TO TRACK!!

There is refrigeration for those who need it for their medications and we try always to have a nurse or physician at the track for each event. Remember no one under 18 is to be at the track without a parent with them.
